	16122	SILSBE	Are cars that are attended by a crew member from the ground required to be secured against undesired movement?	No, as long as equipment is not left unattended. Unattended means cars and/or locomotives left standing and unmanned in such a manner that the brake system of the cars and/or locomotives cannot be readily controlled. 	16124	CLOVIS	Must all dimensional shipments be placed in a solid block next to the lead locomotive consist?	To provide for close observation enroute, all dimensional shipments must be placed in a block next to the lead locomotive consist or as near the lead locomotive consist as possible. Dimensional shipments, coupled with idler cars weighing less than 45 tons, must be placed in compliance with train make-up rules and placed as close as possible to the lead locomotive consist. On trains destined to or operating in the state of California, and train room permits, dimensional shipments must be no closer than the 6th car or platform from the lead locomotive consist.	SSI	Item 7
	16127	GALLUP	Where must the mid DP consist be cut in on a solid intermodal train operating with one DP remote consist?	A single DP remote consist cut into the train must not have the cut in DP consist further than 10,000 feet from the head end of train (excluding locomotive length). On solid intermodal trains, the DP remote consist must be cut in no closer than 1,000 feet forward of mid train by length, as long as train makeup requirements next to DP remote consist outlined in item 47(A)3 and 4 are met. 	16131	RIVER	Is the weight of isolated locomotives used when calculating trailing tonnage for train make up requirements?	No. When complying with Special Instructions covering speed and other train restrictions where calculations of train length, tonnage and/or tons per operating brake are involved, the locomotive consist should be excluded unless specifically stated otherwise. 	16133	STCROI	Must all air hoses be coupled and hand brakes released in a yard track, when a setout is performed and the yard track does not need to be moved?	No. Perform a securement test on cars set out of train.	ABTH	102.1.2
